- New Dashboards for Vendors: The new Enhanced vendor performance dashboard gives users a comprehensive overview of activities on which the attorneys are spending their time at the firm level. Whereas the Vendor Comparative Dashboards allow comparing the firm performance side-by-side on various factors like Diversity, Fees, Expenses, Guidelines Compliance, and Rates.
- MitraCode Rule Projected Savings Report: The MitraCode Rule Projected Savings Report, provides information about the InvoiceIQ module performance and potential savings in the client's environment. Gain valuable insights to optimize cost-efficiency and drive profitability.
- Improved InvoiceIQ module Configuration and MitraCode rule settings: This enhancement has added new fields and functionalities to provide a better user experience.
