Evaluation Methods Used: Conformance to the listed accessibility standards has been evaluated using a combination of static analysis tools and manual testing with assistive technologies. The following operating system, browsers, toolsets, and screen readers are used for evaluation: Windows 10, JAWS 2022/Chrome, ZoomText 2022, Dragon NaturallySpeaking 15, manual accessibility testing, and keyboard testing with visual focus.
